## Dear Chief of BMPS,

Good day. I am writing respectfully to request information and clarity regarding any blotter entries, complaints, or police actions that may have involved me in connection with my son, **Adri'el Degillo Peterson**.

I would like to know whether your station has:

- Received or recorded any complaints, blotters, or incident reports involving my name, particularly relating to custody, domestic disputes, or parental issues; and
- Taken part in any actions or coordination involving the removal, transfer, or concealment of my son without a court order or peaceful mediation.

As the **biological father and legal guardian**, and in the **absence of any court-issued custody order**, I am seeking clarity as a concerned and responsible parent.

This request is made in line with:

- Article III, Section 7 of the 1987 Constitution, granting access to public records;
- The Data Privacy Act of 2012 (R.A. 10173), which allows a data subject access to information involving them;
- And the **Family Code of the Philippines**, **Articles 211–213**, which provides that both parents share equal parental authority unless modified by court order.

## **Additional Notes for Context**

My estranged wife, **Anngeneth Degillo Peterson**, has a history of abandonment, dishonesty, and emotional manipulation. She suddenly removed our child from

my care on **February 17, 2025**, while I was in the middle of relocating to a new residence nearby. There was no peaceful agreement, mediation, or court involvement. I was never informed of her intention to take our child, and no explanation or legal basis was provided.

Shortly after, my mother-in-law also entered my room without consent and took personal belongings including money and my child's birth certificate and our marriage certificate, which has since been returned.

Due to Anngeneth's history of neglecting her child for extra-marital affairs over a 6 month period while holding primary custody, I'm deeply concerned for the safety of my child, where he's at, and who is watching him, which has gone on now for 51 days of parental alienation. I've attempted to communicate with her, but she and her family ignore every request to see my child or ask about his welfare. Instead I receive BPOs with my son's name included.

These events raise deep concerns that due process was not followed, especially since RTC Dumaguete confirmed no cases or court orders exist involving my son or I.

## **Action Requested**

Please let me know if:

- Any such reports or complaints exist,
- If there was **any coordination or assistance provided by your station** during or after the child's removal,
- Or, if no record exists, kindly issue a Certification of No Record.

I am fully willing to **present valid identification in person** when retrieving these documents. Please confirm receipt of this request and advise if any forms, procedures, or fees are required.

Thank you for your time and transparency. I am committed to resolving these issues peacefully, legally, and with full respect for all parties.
