Subject: Request for Official Blotter Entry and Assistance in Reclaiming Custody of My Son

Dear Chief of Bacong Police,

I am writing to formally request your assistance regarding the **unlawful and irregular removal of my son, Adri'el Degillo Peterson**, from my custody. I respectfully seek the official blotter entry that I was **previously denied on two separate occasions** at the Bacong Police Station, and I ask for your support in restoring my son to a safe and lawful environment under my care.

Overview of Events:

On or around **February 17–18, 2025**, while I was in the process of moving our belongings to a more stable and peaceful home for my son, his mother, Anngeneth Degillo Peterson, with the aid of her family and Barangay Sacsac, removed him from my custody **without my consent, without due process, and without any valid court order or legal authority to do so**.

Please note that:

- **Article 211 of the Family Code** of the Philippines clearly states:

"The father and the mother shall jointly exercise parental authority over the persons of their common children. In case of disagreement, the father's decision shall prevail, unless there is a judicial order to the contrary."

To date, there is **no judicial order** removing or suspending my parental rights.

- The **DSWD** allowed the mother and her family to conceal my child for **over 54 days and counting**, violating the **maximum 5-day hold rule** for children taken without court orders or formal case initiation. This violates their own internal **Child Protection Standards and Custody Protocols** as well as **RA 7610 (Special Protection of Children Against Abuse, Exploitation and Discrimination Act)**.
 - Despite **two personal attempts to file a blotter** regarding this unlawful taking at the Bacong Police Station, I was **denied** the ability to make a record — a violation of my right under **RA 6975**, which governs the **duties of the PNP** to receive reports of criminal or civil violations.

Legal Missteps and Fabricated Story

It is my belief that the mother, Anngeneth, **provided a fabricated narrative to Barangay Sacsac** in order to bypass my legal rights and obtain Barangay Protection Orders (BPOs) solely based on hearsay. There was no formal investigation, no cross-checking, and no due process followed.

No person shall be deprived of life, liberty, or property without due process of law, nor shall any person be denied the equal protection of the laws. Art III, Sec. 1, 1987 Philippine Constitution

The fact that **no custody case is currently filed at the RTC**, and that **I have been the child's primary caregiver for the majority of his life**, further reinforces that this was an illegal and emotionally harmful removal.

My Request

In light of these events, I respectfully request the following:

1. **To now file and document an official blotter** at Bacong Police Station for the unlawful removal of my son on February 17, 2025.
 2. **Assistance from the PNP** in returning my son to me, in accordance with the Family Code and in absence of any court order depriving me of custody.
 3. Optional but encouraged: Initiation of an **investigation** into the prior denial of my blotter requests and the involvement of government agencies in enabling this irregular action.

Conclusion

I remain committed to cooperating with all legal procedures and protecting the best interests of my son. This letter is not to escalate conflict, but to restore my son's right to stability and my right as a parent under Philippine law.
