Subject: Request for Transparency and Legal Clarification Regarding Child Custody Case

Dear Ms. Judy Ann T. Maceda and Ms. Maria Rizza N. Bayona,

I hope this message finds you well. I am writing in response to the letter dated April 11, 2025, that I received regarding the case conference invitation and the steps taken in relation to my concerns about the custody and welfare of my child, Adri'el Degillo Peterson.

While I appreciate your efforts to coordinate with the Municipal Social Welfare and Development Office (MSWDO) and the Barangay Captain of Sac-Sac, I must express my concern that the proceedings to date have been both unclear and lacking the necessary legal transparency.

Firstly, the letter makes no reference to a formal case file or case number associated with this matter. For me to fully understand the legal standing of this process, I require that an official case number and case file be provided as per due process. Without such documentation, I cannot move forward with this case with any sense of clarity or assurance that the actions taken

are in accordance with the law.

Secondly, while I understand that a case conference is scheduled for April 14, 2025, I must reiterate that the purpose of the meeting and the agenda have not been sufficiently clarified. I request that you provide a detailed agenda for the upcoming meeting, including the legal basis for any actions that have been taken or proposed thus far.

Furthermore, I would like to express my concern regarding the involvement of my estranged wife, Anngeneth Degillo-Peterson, in this matter prior to the conference. It appears there may be a lack of neutrality in the handling of this case, as she was contacted and invited before I was informed. Given the nature of our ongoing legal disputes and her previous behavior, I believe it is important to ensure that this process remains unbiased and fair to all parties involved.

I would also like to remind the DSWD of my rights as a parent. As outlined in the Family Code, particularly Article 211 (<u>https://chanrobles.com/executiveorderno209.htm</u>), the child's custody and welfare should be governed by the best interest of the child, and I am fully committed to ensuring that Adri'el is placed in a safe and supportive environment. I would appreciate it if you could acknowledge and adhere to the legal requirement of custody processes and transparency.

Lastly, as there is currently no clear case file or legal foundation to this process, I cannot comply with attending any meetings or further proceedings until I have received an official case number, a formal record of the proceedings since before Feb 17th, 2025 to date, and assurance that this case is being handled in accordance with the law.

I trust that the DSWD will take the necessary steps to ensure that this matter is handled in a legally sound manner and that the well-being of my child is the primary focus. I look forward to your response and the formalization of this case.
