Dear Honorable Administrator,

I am writing to respectfully request review and oversight regarding potential attorney misconduct and improper judicial coordination surrounding a custody-related matter involving **Barangay Protection Orders (BPOs)** issued in early 2025.

BPOs were filed against me at **Sacsac Barangay, Bacong, Negros Oriental**, where I, **Jordan James Peterson**, was the named respondent.

In the sworn affidavit **attached to the second BPO**, Ms. Degillo explicitly stated:

> *“Mag-advise ang abegado nga ipa-extend ang BPO, arun ma-aware ko ug dag bata.”*
> *(My lawyer advised me to extend the BPO so I could gain awareness of the child.)*

This statement implies that legal counsel was used not for protection, but to manipulate custody without judicial process. Given the surrounding context—including:

- Lack of formal custody case filings,
- Sudden coordinated silence among local institutions (Barangay, Police, DSWD),
- And unusual alignment of narrative without court summons or investigation—

I respectfully request that your office:

1. Investigate any involvement of attorneys in advising Ms. Degillo on BPO misuse,
2. Determine whether any court, clerk, or judge received informal communication that bypassed due process,
3. Review if the conduct of any officer of the court—formally or informally—violated judicial integrity or constitutional parental rights.

This letter is part of a good faith effort to uncover whether my child’s custody was altered through improper legal shortcuts and silencing of my parental voice without any filed case, hearing, or order.

I have already contacted the RTC Dumaguete and the IBP – Negros Oriental chapter. I am now placing this matter before your honorable office in full respect and in pursuit of lawful justice and oversight.
